


2 IT Service Status






Overseas Expansion by Country

 - Project participation of domestic IT service companies are ranked the lowest in Global market (World Bank, IDB, UNDP, International Organization)
- A. WB Project scale in 2009 \$24.5 billion : EDCF \$4.6 billion(Execution scale)
 - Short-term EDCF business focus structure of oriented conditional Tied Roan
- B. For the last 3 years, Over \$10 Million, IDB(Development Bank Project Direct Performance)
 - Exist only one project of parent company /Lowest rate of Project Order and Participation rate in OECD countries
- C. Non-exist UN affiliated organization and UNDP ICT relevant Project Exclusive Performance Experience
 - Around 1% of Company and Government Organization registered to UN affiliated organization legally as a Vendor




